REVIEW OF DUTY TOUR ALLOWANCE IN THE FEDERAL PUBLIC SERVICE

The President of the Federal Republic of Nigeria has approved the upward review of Duty Tour Allowances applicable to Permanent Secretary/Equivalent from N20,000 to N70,000, and to Minister/SGF/HCSF/Equivalent from N35,000 to N80,000. This approval takes effect from 1st September 2022.

2. Given the above, and further to our Circular No. SWC/S/04/S.6/II/208 dated 2nd February 2022 on the above-mentioned subject, the comprehensive list of officers and their Duty Tour Allowances are as follows:-
