

NEITI's IMPLEMENTATION OF FREEDOM OF INFORMATION ACT JANUARY 2018 - DECEMBER 2018

INTRODUCTION

1. Section 29 of the FOIA 2011 which mandated all federal agencies to forward their annual report of implementation of the Freedom of Information Act to the Office of the Attorney General of the Federation and Minister of Justice, refers.

2. Please find forwarded a report of implementation of the Act from January 2018 to December 2018.

3. Under the FOI compliant portal, now in place and in use, NEITI received only two (2) FOI requests from the public. This may be adduced to NEITI proactively disclosure of relevant public information on the website.

Achievements:

4. In the year under reporting, NEITI was ranked 2nd among 800 institutions in the implementation of the FOI Act by the Right to Know (R2K) and also ranked 3rd in the proactive disclosure of procurement information by the Private Public Partnership (PPDC) in its 2018 ranking exercise among public institutions accessed.
